Dear Mr. Seeley:

For the reasons indicated in an e-mail note from Ms. Stephanie Stephens of your program, the container label and the use restriction bulletin included in the amendment application of July 13, 2010, were replaced by revised documents supplied via the amendment application of August 23. 2010, and by e-mail on August 20, 2010. The elements of labeling on August 23, 2010, were replaced by corresponding documents submitted on September 30, 2010. In turn, those elements were replaced by corresponding documents submitted on October 7, 2010, in response to communications between Ms. Stephens and Dr. William Jacobs of our office. Therefore, the container labels, capsule labels, and use restriction bulletins submitted on July 13, 2010, August 20, 2010, August 23, 2010, and September 30, 2010, are not accepted and are not considered further in this letter.

The labeling submitted for this product on October 7, 2010, is accepted under the provisions of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended. This labeling includes the container label, the label for individual capsules, and the bulletin of "M-44 Use Restrictions" dated "October 7, 2010".

Stamped copies of all 3 elements of this product's labeling are enclosed for your records.

Submit two copies of all 3 elements (container and capsule labels plus Use Restriction bulletin) of final printed labeling before releasing this product for shipment under the labeling accepted via this letter. Product released for shipment after October 12, 2011, must bear the labeling accepted via this letter.

If these conditions are not complied with, this registration will be subject to cancellation in accordance with FIFRA section 6(e).

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### DANGER

Sodium cyanide may be fatal if swallowed or inhaled. Use only with adequate ventilation and do not breathe the gas or dust. When handling, setting out or checking M-44 cyanide capsules, always have at least six pearls of Amyl-Nitrite readily available in case sodium cyanide is swallowed or inhaled.

While handling sodium cyanide capsules, protect hands with gloves and shield eyes to prevent eye burns and skin irritation. Wash thoroughly before eating or smoking.

Do not use in areas frequented by humans or domestic dogs.

#### **ENVIRONMENTAL HAZARDS**

This pesticide is TOXIC TO WILDLIFE. Keep out of lakes, ponds or streams. Do not contaminate water by cleaning of equipment or disposing of wastes. The M-44 ejector device may not be used in areas inhabited by endangered canids and felids.

#### **CHEMICAL HAZARDS**

Contact with acid liberates poisonous and flammable hydrogen cyanide gas.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For use in specific situations to reduce arctic fox that depredate Federally designated threatened or endangered species. For use in the Aleutian Islands, Alaska only. Do not place in areas where food crops are planted. Do not use within 200 feet of the median high tide.

**IMPORTANT:** Before handling or placing M-44 cyanide capsules or M-44 ejector devices, consult the Use Restriction Bulletin (revised October 7, 2010) for specific use directions, additional precautions, information on endangered species, warning signs and antidotal measures.

<u>WARNING SIGNS</u>: Bilingual (Spanish/English) warning signs must be posted in the general area and at the application site.

#### RESTRICTED USE PESTICIDE

#### STORAGE AND DISPOSAL

**PESTICIDE STORAGE:** Store M-44 cyanide capsules under lock and key in a dry place away from food, domestic animals and acids. Do not contaminate feed or food stuffs.

PESTICIDE DISPOSAL: Dispose of defective and used M-44 capsules by burial in a safe location in the field or at a proper landfill site. Incineration may be used instead of burial for disposal of used capsules. Place capsules in an incinerator or refuse hole and attend the burn until the contaminated material is completely consumed. If burned, stay out of smoke.

CONTAINER DISPOSAL: Styrofoam Container: Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. If container is not to be recycled, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance in disposing of container at approved hazardous waste disposal facilities.

### ENDANGERED SPECIES CONSIDERATIONS

Use of this product is prohibited in areas where such use might jeopardize the continued existence of endangered species.
