TB-65 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5 TB-65 per gallon is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.7 TB-65 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in a cool, dry place. Do not store in damaged drums should be placed in overpack. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
