

## PRECAUTIONARY STATEMENTS HAZARDS to HUMANS AND DOMESTIC ANIMALS

### CAUTION

Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling.

Avoid contact with contents of pouch; do not puncture pouch. Avoid inhaling fumes; prior to use, open storage bag and thoroughly vent in a well ventilated area.

#### Personal Protective Equipment (PPE)

- Applicators and other handlers must wear:
  - long-sleeved shirt and long pants;
  - shoes plus socks and waterproof gloves.
- Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them. Wash PPE with detergent and hot water. Keep and wash PPE separately from other laundry.

#### User Safety Requirements

- Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.

#### TRANSPORT AND HANDLING

- Transport in sealed storage bag (provided).
- Transport in ventilated portion of the vehicle sectioned off from the passenger compartment.
- Pre-vent bags as described above.

#### SPILLS AND FIRE

- In cases where the active ingredient is released, wipe up with absorbent cloth and remove to well ventilated area.
- Wear protective gloves when cleaning. Wash the outside of gloves before removing.
- In case of fire, extinguish with CO<sub>2</sub>, foam or dry chemical extinguishers.

#### Host Tree Stands

**Mountain Pine Beetle:** Tree stands containing ponderosa, lodgepole, limber, western whitepine, pinyon, whitebark and other western pine trees.

**Southern Pine Beetle:** Tree stands containing loblolly pine, shortleaf pine, Virginia pine, and other southern pine trees.

#### Pest

- Mountain Pine Beetle (*Dendroctonus ponderosae*)
- Southern Pine Beetle (*Dendroctonus frontalis*).

#### Effect

- Verbenone is an antiaggregation pheromone for the listed pests. Verbenone Pouches prevents mass attack by these pests and can work to protect susceptible trees.

#### Use Pattern

Do not expand the use pattern for this product to include habitat of endangered Coleopteran species without prior consultation with the U.S. Fish & Wildlife Service. Do not use this product in the State of California because of the existence of endangered species.

#### Application Rate

Place in grid pattern, preferably on standing susceptible trees.

- minimum dose 1 pouch/tree (4.65 g active ingredient/tree)
- maximum dose 6 pouches/tree (28 g active ingredient/tree)

#### Timing

- Place Verbenone Pouches along the leading edge of expanding infestations as soon as possible.

#### Expected Lifespan

- 25-40 days, weather dependent.
