STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED - Call a physician or Poison Control Center.

IF ON SKIN - May cause skin reactions in rare cases. If so, wash thoroughly with soap and water. Get medical attention if irritation persists.

IF IN EYES - Flush with plenty of water. Get medical attention if irritation persists.

3. Submit a brief description of the formulation process.

4. A storage stability study must be submitted. The formulated product must be analyzed for its active ingredient at time zero and for 1 year of storage. These data must be submitted within 15 months of the date of this Registration Notice.

5. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Storage and Disposal

Storage: Store in a cool dry area away from heat or open flame.

Disposal: Do not re-use empty container. Wrap container and put in trash collection.

To repel the insects listed on the Front Panel, first remove protective cap. Hold can at least 12 inches away, point valve in desired direction and press button to spray. Apply liberally to all exposed skin areas. To apply to face, spray on hands and rub on. Repeat as needed. For ticks and chiggers, also apply liberally to shoe tops, socks and around openings in clothing.

Avoid contact with plastics, such as eyeglass frames, and such fabric as acetate rayon.
