

STATEMENT OF PRACTICAL TREATMENT: In case of eye or skin contact, immediately flush with plenty of water. Get medical attention if irritation persists. DIRECTIONS FOR USE

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

MIXING:

DO NOT use Checkmate-PBW from damaged, punctured or unsealed containers.

Use piston, diaphragm or centrifugal pumps ONLY. DO NOT use roller or gear pumps as they will damage Checkmate's controlled release system. Remove all screens before mixing and/or application.

Add sticker of choice approved for growing crops, according to the label, to the recommended amount of water (see METHODS OF APPLICATION) and agitate. Lastly add Checkmate-PBW to the tank and mix thoroughly. For best results, apply immediately after mixing.

METHODS OF APPLICATION:

GROUND EQUIPMENT: Apply Checkmate - PBW in 5-15 gal water/acre. Apply to foliage directly over the top of every other row using 40-45 psi and FloodJet nozzles, type TK 5, D-6, or larger. AERIAL EQUIPMENT: Apply Checkmate-PBW in 3-10 gal water/acre. Apply to fields from a height of 10-30 feet using 30-60 psi and 406 FloodJet nozzles, type TK 5 to TK 30 or without nozles.

RINSE ALL EQUIPMENT WITH CLEAN WATER IMMEDIATELY AFTER APPLICATION TO REMOVE REMAINING STICKER.

COTTON: To disrupt the mating of pink bollworm, apply 5 grams for light to moderate infestations, 6 grams for moderate to heavy infestations, 8 grams for severe infestations, based on field history, of Checkmate TM PBW per acre. Begin application at pinhead square stage. Reapply every 20 days or sooner, as needed, based on insect monitoring and field scouting programs.
