Cotton: To disrupt the mating of pink bollworm moths, apply 5 grams for light to moderate infestations, 6 grams for moderate to heavy infestations, 8 grams for severe infestations, based on field history, of CheckMate® PBW per acre. Begin application at pinhead square stage. Reapply every 20 days or sooner, as needed, based on insect monitoring and field scouting programs.

If there are any WPS changes, you must incorporate the required language into this label for any shipments released after the deadlines that have been established.
