The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act is acceptable subject to the following comments.

1. Delete General Classification.
2. Move Do not contaminate water, food or feed by storage or disposal. so that it is directly under the storage and disposal heading.
3. Provide separate container disposal statements for each type of container used, i.e. glass, metal and plastic. Use the language designated in PR Notice 83-3.
4. Move Reseal containers immediately after use, store resealed containers in a refrigerator or freezer. to the storage section and modify this statement to read Reseal containers immediately after use, store resealed containers in a locked nonfood storage refrigerator or freezer.

Reseal containers immediately after use, store resealed containers in a refrigerator or freezer. Do not use **OFM TECHNICAL PHEROMONE** from damaged, punctured or unsealed containers.
