### DIRECTIONS FOR USE - General Classification

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. ### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 29 CFR part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. **MIXING:** DO NOT use Consep SPR2 Oriental Fruit Moth Pheromone Sprayable from damaged, punctured or unsealed containers. Use piston, diaphragm or centrifugal pumps ONLY. DO NOT use roller or gear pumps as they will damage the controlled release system. Remove all screens (pumps/application equipment) before mixing and/or application. If sticker is used, first add the approved sticker at the recommended rate and then add Consep SPR2 Oriental Fruit Moth Pheromone Sprayable to the tank and mix thoroughly. For best results, apply immediately after mixing. Do not let stand prior to application without thoroughly mixing again.  
**METHODS OF APPLICATION:** Ground Equipment: Remove all screens (pumps/application equipment) before mixing and/or application. Apply Consep SPR2 Oriental Fruit Moth Pheromone Sprayable alone or as a tank mix with other pesticides in sufficient water for uniform coverage. Apply to foliage using disc type or round orifice nozzles with a minimum orifice diameter of 0.041 inches [Alternate: different numbers may be used depending upon size of bead and type of equipment, i.e. 0.041, 0.063, 0.094, etc.].  
Aerial Equipment: Remove all screens (pumps/application equipment) before mixing and/or application. Apply Consep SPR2 Oriental Fruit Moth Pheromone Sprayable alone or as a tank mix with other pesticides in sufficient water for uniform coverage. Apply to foliage using disc type or round orifice nozzles with a minimum orifice diameter of 0.041 inches [Alternate: different numbers may be used depending upon size of bead and type of equipment, i.e. 0.041, 0.063, 0.094, etc.].

**APPLICATION TO PEACHES, NECTARINES, APRICOTS, PLUMS, AND OTHER STONE FRUITS; APPLES, QUINCES, AND OTHER POME FRUITS; OR ANY OTHER CROPS WHERE THE ORIENTAL FRUIT MOTH IS A PROBLEM; TO ALMONDS, MACADAMIAS AND OTHER TREE NUTS, OR ANY OTHER CROPS WHERE THE MACADAMIA NUT BORER OR KOA SEEDWORM ARE A PROBLEM:** To disrupt the mating of these pests, apply Consep SPR2 Oriental Fruit Moth Pheromone Sprayable at 19 gms product (10 gms a.l./acre) per acre to 90 gms product (50 gms a.l./acre) per acre, depending on infestation pressure [Alternate: single numbers or different ranges between 10 gms a.l./acre and 50 gms a.l./acre may be used]. Do not exceed 272 gms product/acre/year (150 gms a.l./acre/year). Reapply as needed based on insect monitoring and field scouting programs.

### STORAGE AND DISPOSAL

**Do not contaminate water, food or feed by storage or disposal.**  
**PESTICIDE STORAGE** - Store container in cool place until used. Freezing will extend product shelf life indefinitely.  
**PESTICIDE DISPOSAL** - Wastes resulting from use of this product may be disposed of on-site or at an approved disposal facility. Do not contaminate water when disposing of equipment wash water.  
**CONTAINER DISPOSAL** - Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
