CheckMate® PTB-XL Dispenser is a behavior modifying biochemical product (pheromone) which functions by mating disruption. It is to be used in pest management programs for control of peach twig borrer (Anarsia limeatella). The PTB pheromone is contained in, and released from, a solid matrix hand applied dispenser.

METHOD OF APPLICATION

For use on peaches, nectarines, apricots, plums, prunes, cherries and other stone fruits; almonds and other tree nut crops. The rate of application of **CheckMate PTB-XL Dispenser** is 100-200 dispensers per acre. For best nut drops. The late of application to Checkmad PIPAL Disperse is 100-200 dispersers per acte. In moderate to night insect pressure situations, supplemental insecticide applications during the season to provide adequate protection to developing fruit, must be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae.
