To disrupt mating of the pink bollworm moth on cotton, apply Consep SPR5M PBW Pheromone Sprayable at 0.309 fluid ounce (9.14 ml) product (2 gm a.i./acre) per acre to 1.546 fluid ounces (45.72ml) product (10 gm a.i./acre) per acre [*Alternate: single numbers or different ranges between 2 gm a.i./acre and 10 gm a.i./acre may be used*]. Do not exceed 23 fluid ounces (680.20 ml) product/acre/year (150 gm a.i./acre/year). Begin application at pinhead square stage of plant growth. Reapply as needed based on insect monitoring and field scouting programs.

MIXING and APPLICATION: SHAKE WELL BEFORE USING. DO NOT use Consep SPR5M PBW Pheromone Sprayable from damaged, punctured, or unsealed containers. Use piston, diaphragm, or centrifugal pumps ONLY. DO NOT use roller or gear pumps as they will damage the SPR5M controlled release system. For best results, apply immediately after mixing. Do not let stand prior to application without thoroughly mixing again. **Ground Equipment:** Apply Consep SPR5M PBW Pheromone Sprayable in sufficient water for uniform coverage. Do not apply to point of runoff. Apply to foliage directly over the top of plants. **Aerial Equipment:** Apply Consep SPR5M PBW Pheromone Sprayable in sufficient water for uniform coverage.
