

METHOD OF APPLICATION: To disrupt mating of the tomato pinworm on tomatoes, apply CheckMate TPW-F at 1.182 [1.2] fluid ounces (34.934 [35] ml) product (8 gm a.i./acre) per acre to 5.908 [6.0] fluid ounces (174.672 [174.7] ml) product (40 gm a.i./acre) per acre [*Alternate: single numbers or different ranges between 8 gm a.i./acre and 40 gm a.i./acre may be used*]. Do not exceed 22.156 [22] fluid ounces (655.021 [655] ml) product/acre/year (150 gm a.i./acre/year).

If application occurs following biofix or during the growing season, the field must be treated with insecticide treatments that will effectively control hatching larvae until egg laying by previously mated female moths has ceased to occur. In moderate to high insect pressure situations, supplemental insecticide applications during the season may be necessary to provide adequate protection to developing fruit. These supplemental insecticide applications should be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae.
