The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

At this time, the U.S. Environmental Protection Agency (EPA) is not requiring a change to the restricted-entry interval (REI) of 0 hour as it appears on your labeling in the Agricultural Use Requirements Box. The EPA is currently developing guidance and criteria for when it will allow a REI of less than 4 hours and might require a change to the REI for this product in the future. This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the

DIRECTIONS FOR USE

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For requirements specific to your state or Tribe, consult the State or Tribal agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS - Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE). The requirements in this box apply to uses of this product that are covered by the Worker Protection Standard. Do not enter or allow worker entry into treated areas during application of this product. A restricted entry interval of 0 hours has been established.

METHOD OF APPLICATION: To disrupt mating of the oriental fruit moth on peaches, nectarines, apricots, plums, prunes, cherries and other stone fruits; apples, quinces, and other pome fruits; or any other crops where the oriental fruit moth is a problem; to almonds, macadamias and other tree nut crops or other crops where the oriental fruit moth, macadamia nut borer or koa seedworm are a pest, apply **CheckMate® OFM-F** at 0.732 [0.73] fluid ounces (21.645 [22] ml) product (5 g a.i./acre) per acre to 5.875 [5.9] fluid ounces (173.160 [173.2] ml) product (40 g a. i./acre) per acre. [Alternate: single numbers or different ranges between 5 g a.i./acre and 40 g a.i./acre may be used]. Do not exceed 21.961 [22] fluid ounces (649.351 [649 ml]) product /acre / year (150 g ai./acre/year).

SHAKE WELL BEFORE USING

DO NOT use **CheckMate OFM-F** from damaged, punctured, or unsealed containers. Use piston, diaphragm, or centrifugal pumps ONLY. **DO NOT** use roller or gear pumps as they will damage the **CheckMate OFM-F** controlled release system. For best results, apply immediately after mixing. **DO NOT** let stand prior to application without thoroughly mixing again. **DO NOT** apply this product through any type of irrigation system.

Ground Equipment: Apply **CheckMate OFM-F** in sufficient water for uniform coverage. Do not apply to point of runoff. Apply to foliage directly.

Aerial Equipment: Apply CheckMate OFM-F in sufficient water for uniform coverage.

APPLICATION INSTRUCTIONS: For best results, apply at the time or shortly before oriental fruit moths, macadamia nut borer moths or koa seedworm moths begin to emerge in the spring (biofix), or when the moths are first detected in pheromone traps such as **BioLure**[®]. This product only affects male moths and will have no effect on female moths, eggs or larvae. If application occurs following biofix or during the growing season, the orchard must be treated with insecticide treatments that will effectively control hatching larvae until egg laying by previously mated female moths has ceased to occur. In moderate to high insect pressure situations, supplemental insecticide applications during the season can prove necessary to provide adequate protection to developing fruit. These supplemental insecticide applications are to be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae. Monitor for insect infestation with traps and by visual inspection of trees and fruit. Re-apply **CheckMate OFM-F** as needed, based on monitoring results and field scouting.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if absorbed through the skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Harmful if inhaled. Avoid breathing vapor or spray mist. Remove contaminated clothing and wash before reuse.
