The use of approved stickers improves the adherence to the leaf surface and even distribution of the product on plant surfaces. In the event of rainfall or overhead irrigation, re-treatment will be necessary to maintain effective mating disruption. The use of pheromone baited traps will be necessary to make this determination. This product only affects adult male moths and will have no effect on female moths, eggs or larvae. If application occurs following biofix or during the growing season, the field must be treated with insecticide treatments that will effectively control hatching larvae until egg laying by previously mated female moths has ceased to occur. In moderate to high insect pressure situations, supplemental insecticide applications during the season may be necessary to provide adequate protection to the developing crop. These supplemental insecticide applications are to be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae.
