The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company’s website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the U.S. Environmental Protection Agency (EPA). If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product’s label, claims made on the website may not substantially differ from those claims approved through the registration

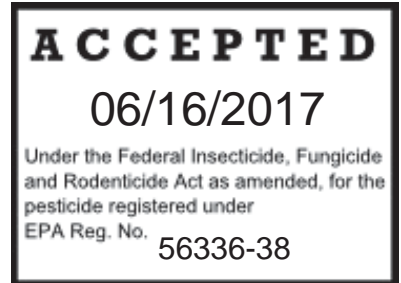

### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40CFR, part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and the restricted-entry interval. The requirements in this box apply to uses of this product that are covered by the Worker Protection Standard. Do not enter or allow worker entry into treated areas during application of this product. Do not enter or allow entry into treated areas during the restricted entry interval (REI) of 4 hours. **METHOD OF APPLICATION:** To disrupt mating of the Navel Orangeworm on almond, pistachio, fig, walnuts and other crops where Navel Orangeworm is a pest apply CheckMate NOW-F at 1.5 fluid ounces (44.4 ml) product (0.5 gm a.i./acre) per acre to 12.0 fluid ounces (354.8 ml) product (4.0 gm a.i./acre) per acre [*Alternate: single numbers or different ranges between 1 gm a.i./acre and 4 gm a.i./acre may be used*] Do not exceed 449 fluid ounces (13,278 ml) product/acre/year (150 gm a.i./acre/year).

**SHAKE WELL BEFORE USING.** DO NOT use CheckMate NOW-F from damaged, punctured, or unsealed containers. Use piston, diaphragm, or centrifugal pumps ONLY. DO NOT use roller or gear pumps as they will damage the CheckMate NOW-F controlled release system. For best results, apply immediately after mixing. Do not let stand prior to application without thoroughly mixing again. Do not apply this product through any type of irrigation system. **Ground Equipment:** Apply CheckMate NOW-F in sufficient water for uniform coverage. Do not apply to point of runoff. Apply to foliage directly. **Aerial Equipment:** Apply CheckMate NOW-F in sufficient water for uniform coverage.

**APPLICATION NOTES:** Reapply as needed based on insect monitoring and field scouting programs. The use of approved stickers is encouraged for improved adherence to the leaf surface and protection from rainfall. In the event of rain, re-treatment is encouraged if approved stickers are not used. This product is not recommended in orchards with overhead irrigation. This product only affects adult male moths and will have no effect on female moths, eggs or larvae. If application occurs following biofix or during the growing season, the field must be treated with insecticide treatments that will effectively control hatching larvae until egg laying by previously mated female moths has ceased to occur. In moderate to high insect pressure situations, supplemental insecticide applications during the season can prove necessary to provide adequate protection to the developing crop. These supplemental insecticide applications should be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae.

## STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** Store container in a cool place until used. Protect from freezing.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed on site or at an approved waste disposal facility. Do not contaminate water when disposing of equipment wash water.

**CONTAINER HANDLING:** Nonrefillable container. Do not reuse or refill this container. Triple rinse (or equivalent), promptly after emptying. Triple rinse as follows: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill container 1/4 full with water and recap. Shake 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities by burning. If burned, stay out of smoke.
