AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40CFR, part 170. METHOD OF APPLICATION: To disrupt mating of the oriental fruit moth on peaches, nectarines, apricots, plums, prunes, cherries and other stone fruits; apples, quinces and other pome fruits; almonds, macadamia, and other tree nut crops; and those other crops where the oriental fruit moth, macadamia nut borer or koa seedworm is a pest apply CheckMate OFM-FXL at 0.9 fluid ounces (27.6 ml) product (5 g a.i./acre) per acre to 7.5 fluid ounces (221 ml) product (40 g a.i./acre) per acre [*Alternate: single numbers or different ranges between 5 g a.i./acre and 40 g a.i./acre may be used*] Do not exceed 28.00 fluid ounces (828.00 ml) product/acre/year (150 g a.i./acre/year). **SHAKE WELL BEFORE USING. DO NOT** use CheckMate OFM-FXL from damaged, punctured, or unsealed containers. Use piston, diaphragm, or centrifugal pumps **ONLY**. **DO NOT** use roller or gear pumps as they will damage the CheckMate OFM-FXL controlled release system. For best results, apply immediately after mixing. Do not let stand prior to application without thoroughly mixing again. Do not apply this product through any type of irrigation system. **Ground Equipment:** Apply CheckMate OFM-FXL in sufficient water for uniform coverage. Do not apply to point of runoff. Apply to foliage directly. **Aerial Equipment:** Apply CheckMate OFM-FXL in sufficient water for uniform coverage.

APPLICATION NOTES: Reapply as needed based on insect monitoring and field scouting programs. The use of approved stickers improves the adherence to the leaf surface and protection from rainfall. In the event of rain, re-treatment may be required if approved stickers are not used. This product is not recommended in fields with overhead irrigation. This product only affects adult male moths and will have no effect on female moths, eggs or larvae. If application occurs following biofix or during the growing season, the field must be treated with insecticide treatments that will effectively control hatching larvae until egg laying by previously mated female moths has ceased to occur. In moderate to high insect pressure situations, supplemental insecticide applications during the season can prove necessary to provide adequate protection to the developing crop. These supplemental insecticide applications should be made based on trap monitoring, field scouting, and appropriate degree-day models for the local growing area and must be timed to control emerging larvae.
