The U.S. Environmental Protection Agency (EPA) is in receipt of your application for notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Biopesticides and Pollution Prevention Division (BPPD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The new primary brand name, "Celada VMB 180," has been added to the product's records. You must submit one (1) copy of the final printed labeling with the modifications.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) and is subject to review by the EPA. If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the EPA find or if it is brought to our attention that a website contains statements or claims substantially differing from statements or claims made in connection with obtaining a FIFRA section 3 registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

FOR TERRESTRIAL USE: Do not apply to water, or to areas where surface water is present or to intertidal areas below the high-water mark.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Celada VMB 180 is a vapor releasing mating disruption product for the control of Vine Mealybug (*Planococcus ficus*) in grapes (wine, table, and raisin grapes) and any other crop where the pest may be present.

METHOD OF APPLICATION

Do not apply more than 150 grams a.i. per acre per year (833 dispensers/acre/year).

Authorized uses:

Crop	Target pest	Number applications	Rate of application
Wine grape Table grape Raisin	Vine Mealybug (<i>Planococcus ficus</i>)	1 per year	200 dispensers per acre

Apply by hand. One application per year is sufficient. It is recommended to perform the application of Celada VMB 180 before the beginning of the first flight to be disrupted (typically in spring). Apply the dispensers by hand to trellis wires, shoots, or branches avoiding direct exposure to the sun. Dispensers are best deployed near the trunk of the vines at cordon height. Distribute the dispensers evenly throughout the vineyard to achieve the desired rate.

Celada VMB 180 is a mating disruption product. The product only affects adult males and will have no effect on females, eggs or immatures.

The use of Celada VMB 180 should always take place in the context of an Integrated Pest Management strategy. The use of other pest control measures may be necessary and should be based on proper pest monitoring and field scouting.

STORAGE AND DISPOSAL

If burned stay out of smoke.

DO NOT contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Store container in cool place until used. Reseal containers immediately after use. Store unused product in a refrigerator or freezer not used for food storage.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on-site or at an approved disposal facility.

CONTAINER DISPOSAL: <u>Plastic Containers</u>: Nonrefillable container. Do not reuse or refill this container. Triple rinse (or equivalent). Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning.
