DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FORMULA 1541 is used to control algae, bacteria, and fungi in recirculating commercial and industrial water cooling towers and systems. Prior to its use, systems must be cleaned to remove algae growth, microbiological slime, and other deposits. An initial slug addition of 6.13 to 15.32 fluid ounces of **FORMULA 1541** per 1000 gallons of water to provide a concentration of 48 to 120 parts per million of **FORMULA 1541**, based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.53 to 15.32 fluid ounces of **FORMULA 1541** per 1000 gallons of water (12 to 120 parts per million of **FORMULA 1541**) should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

FORMULA 1541 is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 24.7 to 41.2 fluid ounces of **FORMULA 1541** per 1000 gallons of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 16.9 to 41.2 fluid ounces of **FORMULA 1541** per 1000 gallons of water should be employed each 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or to the water collection trays of the airwash system.

FORMULA 1541 is used to control the growth of algae in decorative fountains which do not contain fish. For maximum effectiveness, decorative fountains should be cleaned prior to using **FORMULA 1541**. Decorative fountains having just visible algae growth requires an initial dose of 6 to 12 fluid ounces of **FORMULA 1541** per 1000 gallons of water. For treatment of a freshly cleaned decorative fountain, add initially 3 to 6 fluid ounces of **FORMULA 1541** per 1,000 gallons of water. Subsequent additions of 1.5 to 2.4 fluid ounces of **FORMULA 1541** should be made every 5 to 7 days after initial treatment for maintenance.
