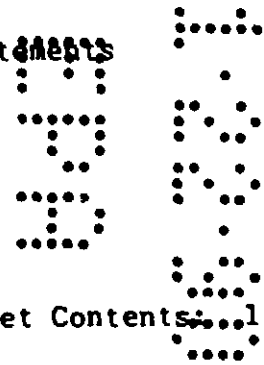

**Statement of Practical Treatment**

If swallowed - Call a physician or Poison Control Center immediately. If possible, vomiting should be induced under medical supervision. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If inhaled - Remove victim to fresh air. Apply artificial respiration if necessary.

If on skin - Remove contaminated clothing and wash skin immediately with soap and water.

If in eyes - Flush eyes with plenty of water. Call a physician immediately.

Note to physician - If signs of cholinesterase inhibition are observed atropine is antidotal and may be administered in conjunction with 2-PAM (Pralidoxime Chloride). Product may cause aspiration pneumonia. Gastric lavage may be indicated if product was taken internally.

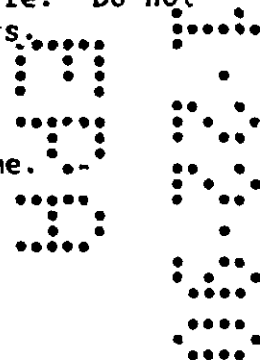

Do not contaminate water, food or feed by storage or disposal.

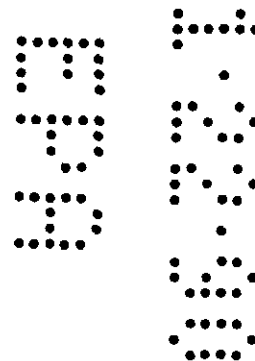
**Pesticide Storage** - Store in original container only. Store at temperatures above 32°F. Do not store above 120°F for an extended period of time.

Pour RAVAP Backrubber Solution into oil reservoir of mechanical rubbing devices or pour one gallon per 20 linear feet on burlap or rope backrubbers. There is no withholding period from last application to slaughter.
