Fleas: For maximum effectiveness, the entire carpeted area should be treated at the rate of 1 qt/500 sq. ft. Adjust spray nozzle to create a line spray. Apply evenly as a spray for spot treatment to infested areas such as pet beds & resting quarters, carpet, rugs, & drapes; nearby cracks & crevices; along & behind baseboards. Old bedding of pets should be removed & replaced with clean, fresh bedding prior to treatment of pet areas. DO NOT TREAT PETS WITH THIS PRODUCT.
