

REMOVE COLLAR FROM PACKAGE, UNROLL AND STRETCH TO ACTIVATE INSECTICIDE GENERATOR



To activate collar hold at each end...STRETCH ...it's ready to work.



It is not advisable to use this collar or similar pesticides on kittens less than 6 weeks of age. Do not unroll collar until ready to use. Place the Americare Rabon Flea & Tick Collar around the cat's neck, adjust for proper fit, and secure in place. The collar must be worn loosely to allow for growth of the cat and to permit the collar to move about the neck. Generally, a properly fitted collar is one that when fastened will snugly slide over the cat's head. Leave 2 or 3 inches on the collar for extra adjustment and cut off and dispose of the extra length. Some animals may become irritated by any collar if it is applied too tightly. If this occurs, loosen the collar. If irritation continues, remove the collar from the animal. This collar is intended for use only as an insecticide generator.

For continuous flea protection under normal conditions, replace the collar every 5 months. Under conditions where cats are exposed to severe flea infestation it may be necessary to replace the collar every 4 months. Ticks, which may be an occasional problem for cats, are harder to kill. The collar's full protection against ticks will be built up within a few days after being placed on the animal. The Americare Rabon Flea & Tick Collar will kill ticks, including the Deer Tick, carrier of Lyme Disease, for 5 months under normal conditions. The cat should be examined from time to time and the collar replaced when mature tick or flea populations begin to appear. Wetting will not impair the collar's effectiveness or pet's protection. If the cat is out in the rain, it is not necessary to remove the collar. The Americare Rabon Flea & Tick Collar may be worn with a regular collar.

DISPOSAL - Do not use empty pouch. Dispose in trash collection.
