

CAUTION: Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Keep out of lakes, streams, or ponds. Permits may be required for discharges containing this pesticide into lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ARGOTREAT MB 40 is used to control bacteria, algae, and fungi in recirculating commercial and industrial water systems. Upon its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 40 fluid ounces of ARGOTREAT MB 40 per 1000 gallons of water to provide a concentration of 40 ppm.

ARGOTREAT MB 40 in the system, is recommended. Repeat initial slug additions of 1.20 ARGOTREAT 40 per 1000 gallons of water.

Subsequent slug additions of 1.20 ARGOTREAT 40 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the system.

ARGOTREAT MB 40 is used in air-washing systems that maintain effective concentrations of 21.37 ARGOTREAT MB 40 per 1000 gallons of water.

Repeat initial dosage until control is achieved. Repeat initial dosages of 14.44 to 35.63 fluid ounces of per 1000 gallons of water should be employed. Frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking drums for disposal. Spills should be absorbed in sawdust or similar material. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of at a government approved waste disposal facility.

CONTAINER DISPOSAL:

PLASTIC: Triple rinse (or equivalent). Then offer for recycling or for disposal in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.

METAL: Triple rinse (or equivalent). Then offer for recycling or for disposal in a sanitary landfill, or by other procedures approved by state and local authorities.
