Dear Mr. Bronson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable.

Please note that the previously accepted Notification, dated March 24, 2014, has been rescinded because the proposed label submitted along with this Notification contained a 12-hour duration against public health pests which was never approved for use on the subject label. In addition, the transmittal letter submitted with the Notification did not clearly articulate that you were adding this duration claim to the subject label.
