Per our conversations, attached is a label update notification for EPA Reg. No. 56601-2, Mildew Check. Two copies of the updated label are attached. For your reference, I have attached a document with all the changes noted in red. The changes made are as follows:

- 1. The EPA establishment number was updated because our Mildew Check packaging location was sold to another company.
- 2. Personal Protective Equipment (PPE) was spelled out for clarity.
- 3. Since we package in small sizes, the Environmental Hazards statement was minimized in the text, but will be added in larger sizes per PR Notice 95-1.
- 4. The brand name's "Multi-Purpose" Wash descriptor was added after Mildew Check in several places.
- 5. "Pittsburgh Paints" was changed to "PPG" in the Limited Warranty.
- 6. Recommended Spray Equipment was updated because the models listed were obsolete.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

Coverage: Approximately 200-250 sq. ft. (18.5-23.2 sq. meters) per gallon of mixed product (3.78L) when applied evenly to a smooth surface. Coverage figures do not include allowance for surface irregularities, porosity, or spray loss.

Area Preparation: Spray all shrubs and foliage liberally with water and cover with plastic or cloth.
