DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ALG-700 is used in recirculating commercial and industrial water treatment systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1 ALG-700 per 1000 gallons is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 0.5 ALG-700 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.
