Your application for amended registration and proposed revised labeling for EPA Reg. No. 56637-1, dated March 31, 1998, have been reviewed. The conclusions of our review are discussed below.

- 1. As long as the placepack material and bait formulation are not changed, the efficacy data previously accepted for this product remain acceptable and sufficient to support the claims made for it.
- 2. Your proposed **outer package label** is acceptable **provided** you modify the label as indicated below.
 - a. If it is necessary to split the "DIRECTIONS FOR USE" between two label panels, cross-reference at the points where the "DIRECTIONS FOR USE" are interrupted and where the section resumes. Cross-references must refer the reader to the appropriate label panels (e.g., "See remainder of DIRECTIONS FOR USE on right side panel" and "DIRECTIONS FOR USE continued from left panel").
 - b. Change "could" to "would" in the "qualifying" statements for the "2x2x2 oz." and the "3x2x2 oz." containers. Under unusual circumstances, the amount of bait provided might kill more rats than the claimed upper limit, but such a result would not be typical.

c. The first sentence of the "Rats:" portions of the "APPLICATION DIRECTIONS:" subsection of the "DIRECTIONS FOR USE" must specify use of "2-8 placepacks per placement" regardless of the size of the package. Therefore, the following footnoted text must be deleted from the master label:

> "Apply 2 to 8 placepacks, 'The <u>8</u> in <u>8</u> placepacks" would be changed to represent the amount of placepacks in the package, when less than 8 placepacks, i.e. 4 or 6.'"

We note that the number of placepacks that a registrant arbitrarily chose to include in a package would have no affect on the amount of bait that might be needed to control the rats which visit any given placement location. For packages containing at least 4 ounces but less than a pound of bait, "qualifying" statements indicate that the amount of bait provided can only be expected to control limited numbers of rats. Those statements enable customers to determine whether they might need to purchase more than one package of bait. This situation differs from that which would occur if the package were smaller than the amount required for a single minimum placement to control rats. In the latter case, the validity of the claim "KILLS RATS" would be called into question, and the product would be considered to be misbranded if the claim appeared on its label.

- 3. Placepacks which contain only two ounces of Diphacinone bait <u>must not</u> be sold individually unless all claims and directions pertaining to the control of rats are deleted, including any reference to rats in the name of the product. Two ounces of bait is only half of the minimum bait placement amount typically indicated for commensal rat control on labels for anticoagulant baits. Claiming control of rats for a container which supplies too little bait to do the job would be misleading.
- 4. Your proposed 2-oz. placepack label is acceptable provided you modify the label as indicated below.

- a. If it is necessary to split the "DIRECTIONS FOR USE" between two label panels, cross-reference at the points where the "DIRECTIONS FOR USE" are interrupted and where the section resumes. Cross-references must refer the reader to the appropriate label panels (e.g., "See remainder of DIRECTIONS FOR USE on right side panel" and "DIRECTIONS FOR USE continued from left panel").
- b. As the proposed qualifying statement applies only to a packaging arrangement which provides 4 ounces of bait, the asterisked material must

be revised to read as follows:

"*For 2x2 oz. packages (including two placepacks joined together with a hole at the top to slip on a pegboard), the following statement will be added: 'The amount of bait in two placepacks is unlikely to be sufficient to kill more than one or two rats.'"

We note that we have had second thoughts about having agreed to permit registrants to use end-to-end packaging arrangements for placepacks and would prefer that placepacks sold in pairs be packaged in an appropriatelylabeled outer container. The revision indicated above accommodates both types of packaging arrangements.

c. The first sentence of the "Rats:" portions of the "APPLICATION DIRECTIONS:" subsection of the "DIRECTIONS FOR USE" must specify use of "2-8 placepacks per placement".

Stamped copies of the outer package label and the individual 2-oz. placepack label are enclosed for your records. Please submit one copy each of your revised final printed labeling for the outer package and the placepack before you release the product for shipment. We caution you to refrain from adding any claims or directions to the final printed label that were not part of the stamped accepted label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
