

NOTE TO PHYSICIAN

ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish, birds, and other wildlife. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff from treated areas may be hazardous to aquatic organisms in adjacent aquatic sites. Cover or incorporate spills. Do not contaminate water by cleaning of equipment or disposal of equipment washwaters.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

IMPORTED FIRE ANT: For treatment of individual fire ant mounds, apply 4 tablespoons uniformly over each mound. Apply gently to avoid disturbing ants. For best results, apply in cool weather, 65°F to 80°F, or in early morning or late evening hours. Treat new mounds when they appear.

GROUP 1: To control Ants, Armyworms, Brown Dog Ticks, Chiggers, Chinch Bugs, Clover Mites, Crickets, Cutworms, Earwigs, Fleas, Grasshoppers, Mole Crickets, Sod Webworms and Ticks, apply 5 lbs per 1,000 sq.ft. Sprinkle at least 30 gallons of water on turf after treatment.

GROUP 2: To control Turfgrass (Hyperodes) Weevil, apply 10 lbs per 1,000 sq.ft. to problem areas in mid-April and again in mid-May or as recommended by your local Agricultural Extension Service Specialist for your area. Sprinkle 30 gallons of water on turf after treatment with product.

GROUP 3: To control White Grubs (European Chafer and Japanese Beetle larvae only), apply 10 to 20 lbs. per 1,000 sq.ft. when grubs are young and actively feeding near the soil surface, usually during late July and A july or as recommended by your local Agricultural Extension Service Specialist for your area. Apply this product uniformly to home lawns and other promental and recreational turf grass areas using any hand or power operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear. To help obtain uniform distribution, apply one-half the required amount of product in one direction, then apply the balance at a right angle. Immediately after application sprinkle the turf with 30 gallons of water per 1,000 sq.ft. so as to wash the granules into the zone of insect infestation.

STORAGE AND DISPOSAL STATEMENTS

STORAGE: Store in an area inaccessible to children. DISPOSAL: Do not reuse empty container. Wrap container and place in trash collections.
