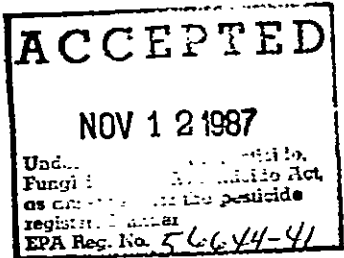

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To control Mole Crickets and also Ants, Armyworms, Brown Dog Ticks, Chiggers, Chinch Bugs, Clover Mites, Crickets, Cutworms, Earwigs, Fleas, Grasshoppers, Sod Webworms and Ticks, apply 200 lbs. per acre in the late afternoon. Apply this product uniformly to home lawns and other ornamental and recreational turf grass areas using any hand or power operated gravity or rotary-type spreader. Treat when insects first appear. For smaller areas, follow rates below:

- 1,000 square feet - apply 5 lbs.
- 5,000 square feet - apply 25 lbs.
- 10,700 square feet - apply 50 lbs.

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food or feed by storage or disposal. Store in an area inaccessible to children and pets. DISPOSAL: Open dumping is prohibited. Pesticide or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. CONTAINER DISPOSAL: Dispose of in an incinerator or landfill approved for pesticide containers or bury in a safe place.
