Purge General Weed Control

A contact, non-selective vegetation killer for the control of broadleaf weeds and grasses.

Precautionary Statements

Do not take internally. May be fatal if absorbed through the skin. Do not breathe spray mist. Do not get in eyes, on skin, or on clothing.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. Induce vomiting by giving victim one or two glasses of water and inserting finger in back of throat. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.
IF INHALED: Remove victim to fresh air. Apply respiration if indicated.
IF IN EYES: Flush with plenty of water. Call a physician.
IF ON SKIN: Remove contaminated clothing and immediately wash skin with plenty of soap and water.

NOTE: Some physicians may discourage use of saline emesis.

ENVIRONMENTAL HAZARDS

This product is toxic to wildlife. Birds and other wildlife in treated areas may be killed. Keep out of lakes, streams, or ponds. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Wear a protective suit of one or two pieces, such as coveralls, worn over work clothing and covering the entire body except head, hands and feet. Wear chemical resistant gloves and chemical resistant footwear during handling (mixing, loading, application, flagging, disposal, etc.) of this product.

USES:

1. General weed control in non-crop areas. Controls broadleaf weeds, brush and grasses. Kills most every type of plant life on contact....it kills through the leaves only.
2. General weed control in shrub areas. Chemical will not injure desirable plants as long as spray does not come in contact with leaves of these plants. Chemical becomes inactive on contact with soil; therefore, plant roots do not take up chemical and chemical does not build up and become toxic at a later date.
3. Spot weed control in lawns and other areas -- will kill undesirable grasses in lawns if these grasses are spot sprayed.
4. General vegetation control around buildings and other installations, gardens, walkways, patios, storage areas, beneath greenhouse benches, fence lines, golf courses, parkways, driveways, ditches, sand traps and similar areas where any type of vegetation is undesirable.

DIRECTION: NON-CROP OR NON-PLANTED AREAS

To kill above ground weed growth around buildings and other installations, gardens, walkways, patios, beneath greenhouse benches, fence lines, golf courses, parkways and driveways for control of undesirable broadleaved and grass type weeds -- 5 gal. per 50 gallons water (13 oz. PURGE per gallon of water). Apply for full coverage and thorough weed contact. Apply preferably to young growth and up to seeding of weeds. Repeat applications necessary to maintain control, particularly on grasses and established weeds. Avoid spray contact with foliage or food crops or ornamental plants. Do not water treated areas for 24 to 36 hours after applications.

STORAGE AND DISPOSAL

STORAGE: Store product tightly sealed in original containers. Store in a cool, dry place which is inaccessible to children or pets, preferably a locked storage area. If crystallization results from storage at cold temperatures, allow product to stand at room temperature for several hours and shake until dissolved.



CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
