An initial slug addition of 26.9 _____ BAC875 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 _____ BAC875 per 1000 gallons every 1 to 5 days, or as needed. The frequency of slug additions should be made in the sump of water cooling systems.
