




Figure 1 To activate the tag, pull off the tabs for insecticide release and air vent.




Figure 2 Place the male stud onto applicator pin until it is well seated. Stud is coated with anti-bacterial formulation.





Figure 3 Place female tag under the clip by depressing lever with collar pointing down.
