DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Disinfecting solution—Mix 13 ounces of Simple Green d per 1 gallon of water (1 to 10 dilution ratio). Make sure surfaces are clean and free of gross filth or heavy soil before applying solution. Solution may be applied by spray, sponge, or mop on counter tops, tables, chairs, floors, walls, garbage pails, and other hard nonporous surfaces in lavatories, bathing areas, locker rooms, kitchens, basements, and laundry areas.

Wet all surfaces thoroughly with solution and wait 10 minutes before rinsing. A fresh solution should be prepared at least daily or more often if the solution becomes diluted or soiled.

Cleaning solution—Mix 8 ounces of Simple Green d per gallon for a multipurpose cleaning solution. Spray, mop or sponge solution on stainless steel, walls, floors, tile, vinyl and appliances to remove grease, dirt and tough stains.

Simple Green d has been formulated for hospitals, hotels, schools, institutions, janitorial and industrial uses. It combines the concentrated cleaning power of Simple Green with a disinfectant that is effective against *Pseudomonas aeruginosa*, *Staphylococcus aureus* and *Salmonella choleraesuis*.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS:
