The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling.

a. Delete the word "Concentrated" from the back and front panel of the product label.

b. On the front panel, correct the spelling of "Deoderizer" to read "Deodorizer".

c. Since the proposed product label contains use directions for HIV-1 (AIDS Virus) which is supported by virucidal data, the word "virucidal" must be listed on the front panel followed by the asterisk (\*).

d. Under the product use directions, the following statement must be listed as the first label instruction for the proposed virucidal claim above "Special Instructions for cleaning and decontamination...":

"Kills HIV-1 (AIDS Virus) on the precleaned environmental surfaces/objects previously soiled with blood/body fluids in healthcare settings or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of human immunodeficiency virus Type 1 (HIV-1) (associated with AIDS)."

e. On the product label, specify the major areas the product is recommended for use (e.g. homes, schools, hospitals). Refer to enclosed DIS/TSS-15 further recommended uses.

f. Indicate the type of surfaces, objects, or items intended for treatment (e.g. floor, walls, bathrooms fixture, surgical instruments.) Refer to enclosed DIS/TSS-15 for further recommended uses.


2. "Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

**FOR DISINFECTING: UP TO 10:1 RATIO** – Surface should be free of gross filth or heavy soil. Mix 10 parts water to 1 part Simple Green d. For convenience: 1 gallon of water to 13 ounces of Simple Green d. Apply solution with sponge, mop, or coarse spray. Allow solution to remain 10 minutes, then rinse thoroughly. Prepare fresh mixture daily, or more often if solution becomes diluted or soiled. To use full strength, wet surface with water first.

Use on all washable, non-porous surfaces. Simple Green d has been formulated for the hospitality and health care industries, athletic facilities, institutions, janitorial/commercial uses. It combines the concentrated cleaning power of Simple Green with a disinfectant that is effective against *Pseudomonas aeruginosa*, *Staphylococcus aureus*, *Salmonella choleraesuis* and human immunodeficiency virus Type 1 (HIV - 1 associated with AIDS).

**NOTE – 10:1 IS THE MAXIMUM DILUTION RATIO WHICH CAN BE USED FOR DISINFECTING PURPOSES. SIMPLE GREEN D CONTINUES TO BE AN EFFECTIVE CLEANER AND DEODORIZER AT HIGHER DILUTIONS, AND LEAVES AREA SMELLING CLEAN AND FRESH.**

**FOR GENERAL CLEANING: 20:1 – MIX 20 PARTS WATER TO 1 PART SIMPLE GREEN D.** Apply with sponge, mc. or coarse spray. Rinse well. Use on floors, walls, tile, vinyl, stainless steel, and appliances to remove grease, dirt, oil, and stains.

**FOR GLASS AND MIRRORS: 150:1 -- MIX 150 PARTS WATER TO 1 PART SIMPLE GREEN D.** Use on windows, glass, mirrors. Rinse. Wipe dry.

### **SPECIAL INSTRUCTIONS FOR CLEANING AND DECONTAMINATION AGAINST HIV OF SURFACES / OBJECTS SOILED WITH BLOOD / BODY FLUIDS**

**PERSONAL PROTECTION:** Use barrier protection methods suitable for handling items soiled with blood or body fluids; disposable latex gloves, gowns, masks, or eye coverings may be appropriate.

**CLEANING PROCEDURE:** Surfaces for disinfection should be thoroughly cleaned of gross filth, heavy soil, and blood and body fluids per the above directions, "FOR DISINFECTING."

**CONTACT TIME:** Follow above instructions, "FOR DISINFECTING."

**DISPOSAL OF INFECTIOUS MATERIALS:** Blood and other body fluids should be autoclaved and disposed of according to local regulations for infectious waste disposal.

### **PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS: CAUTION** Avoid contact with skin, eyes, or clothing. In case of contact, immediately flush eyes and skin with plenty of water. Get medical attention if irritation persists.

### **STATEMENT OF PRACTICAL TREATMENT**

In case of eye contact, immediately flush eyes with plenty of water for at least 15 minutes. Call a physician.

### **STORAGE AND DISPOSAL**

Rinse empty container thoroughly with water and recycle or discard. Do not contaminate water, food or feed by storage or disposal.
