

Make the following corrections to the third page of the label:

1. Revise the first frame to read: "...washable hard non-porous surfaces...stainless steel, chrome, bedframes, bedpans, gurneys, wheelchairs, glazed tile and porcelain, aluminum, glass..." such that your surfaces are in agreement with other text on your label and to delete "fiberglass" which is a porous surface.

In a future submission you may add fiberglass to the label by associating it with specific surfaces which are made of fiberglass and are by their nature hard non-porous such as shower stalls and bathtubs.






