#### SHAKE WELL BEFORE USING

TO KILL WASP, HORNETS, BEES, AND YELLOW JACKETS: Point valve away from face and press button. Hold can at least 3 feet away from the surfaces to be sprayed. Apply in late evening hours when all of the insects have returned to the nest. Remove protective cap. Hold container in upright position to spray. Aim valve opening at nest, hold at arms length and depress button, soaking the entire nest with spray. Spray jet will reach nests up to 20 ft. above ground. Repeat as necessary. Do not use as a space spray.

Wait 30 seconds, then remove nests using a stick or broom handle. Crush insects and nest and place trash collection.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from heat, sparks or open flame.

DISPOSAL: Replace cap. Wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.
