Squeeze gently, directing the fluid under the rim, on the sides, and into the water. Close cap. Brush bowl and flush. Rinse brush in fresh water after use. Clean up any spilled SNO BOL right away. This product is recommended for cleaning and disinfecting toilet bowls. Do not use on bathtubs, wash bowls, other enamel surfaces, chrome or counter tops. Do not set bottle on these fixtures.

For Badly Discolored Bowls - Remove water from bowl and brush out with 4 to 8 oz. SNO BOL. For flush boxes - shut off water flow and flush to empty tank. Squeeze SNO BOL on brush or mop to clean tank.

To Disinfect - Preclean toilet bowl and empty bowl of water. Cover all surfaces with 4 oz of SNO BOL (squeeze approximately 15 seconds). Swab bowl completely, including under the rim. Let stand at least 10 minutes, then flush.
