

**WARNING:** Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

**STATEMENT OF PRACTICAL TREATMENT:** In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WC 610 is used to clean water cooling systems in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 6.9 WC 610 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 WC 610 per 1000 gallons of water every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in a cool, dry place. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums or other suitable containers. Do not use if container is damaged. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Do not use excess pesticide, spray mixture, or rinsate. Do not dispose of wastes in a sewer, by use according to local, state, or federal regulations.
