

Corn Earworm and Fall Armyworm: Apply 1.5 to 2 pounds Methomyl 5G per acre to corn. Use standard granular ground applicators and apply as a banded application, directing granules to the whorl of the plant. Apply when larvae are found in significant numbers in the whorl, from the 4th to 5th leaf stage until tasseling (early growth). Do not apply more than 10 applications per season.

NOTE: Do not graze or feed treated plants to livestock within 3 days after last application.
