P-1235 per 1000 g  
in recirculating commercial and industrial water systems must be cleaned to remove algal and other deposits. An initial slug addition of 5 P-1235 per 1000 g is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.7 P-1235 per 1000 g every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store in live drums high. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpacks. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
