**B.** Solid Set and Hand Move Irrigation Equipment: Determine acreage covered by sprinkler. STIMULATE BUD FORMER PLUS is a biostimulant containing plant growth regulators. STIMULATE BUD FORMER PLUS enhances bud formation by balancing hormone levels in reproductive nodes. It is especially effective when applied with foliar fertilizer, but it is also compatible with pesticides.

**MIXING INSTRUCTIONS:** STIMULATE BUD FORMER PLUS is water soluble and suitable for use in conventional liquid application systems including sprinkler irrigation systems. Shake STIMULATE BUD FORMER PLUS thoroughly and dilute in sufficient water to assure adequate, even coverage without producing excessive runoff.
