#### CHEMIGATION[\*]

#### Application and Calibration Techniques for Sprinkler Irrigation

Apply this product only through the following types of irrigation systems: sprinkler including center pivot, traveler, big gun, lateral move, end tow, side (wheel) roll, solid set, or hand move irrigation; furrow; or drip (trickle) irrigation systems. Do not apply through any other types of irrigation systems. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Experiment Station specialists, equipment manufacturers or other experts. Center Pivot, Traveler, Big Gun, Lateral Move, End Tow, and Side (Wheel) Roll Irrigation Equipment: Operate system and injection equipment at normal pressures recommended by the manufacturer of injection equipment used. Fill tank of injection equipment with water. Operate system for one complete circle for center pivot or one complete run for the other recommended equipment, measuring time required, amount of water injected, and acreage contained in circle or run. Mix recommended amount of product for acreage to be covered into same amount of water used during calibration and inject into system continuously for one revolution or run but continue to operate irrigation system until product has been cleared from last sprinkler head. Spray mixture in the chemical supply tank must be agitated at all times, otherwise settling and uneven application may occur.
- B. Solid Set and Hand Move Irrigation Equipment: Determine acreage covered by sprinkler. Fill tank of injection equipment with water and adjust flow to use contents over a thirty to forty-five minute period. Mix desired amount of product for acreage to be covered into quantity of water used during calibration and operate entire system at normal pressures recommended by the manufacturer of injection equipment used for amount of time established during calibration. Provide constant mechanical agitation in the mix tank to ensure that product will remain in suspension during the injection cycle. Product can be injected at the beginning or end or the irrigation cycle or as a separate application. Stop injection equipment after treatment is completed and continue to operate irrigation system until pesticide is cleared from last sprinkler head.

#### Safety Devices for Sprinkler Chemigation

- (1) The systems designated above must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- (2) All pesticide injection pipelines must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- (3) The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- (4) The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.

**Systems Connected to Public Water Sources** 

- (1) Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of a year.
- (2) Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. - (5) The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops or, in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
- (6) Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- (7) Do not apply when wind speed favors drift beyond the area intended for treatment.

#### In-Furrow Chemigation[\*]

  water at the head of the field and downstream of a hydraulic discontinuity such as a drop

  - d. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
  - e. The irrigation line or water pump must include a functional pressure switch, which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
