

TOWERKLEAN W-10 is used to control bacteria, algae, and fungi in recirculating commercial and industrial water systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 48 fluid ounces of TOWERKLEAN W-10 of water to provide a concentration of 48 TOWERKLEAN W-10 per 1000

in the system, is recommended. Repeat initial Subsequent slug additions of 1.53 TOWERKLEAN W-10 per 1000

120 parts per million of TOWERKLEAN W-10 employed every 2 to 5 days, or as needed. To upon the relative amount of bleedoff and the system. Slug additions should be made in the system.
