



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner

QUAD ALGAEQUELL is used in swimming pools, exterior spas, whirlpools, hot tubs, etc. that do not contain fish. For maximum effectiveness pool decorative fountains, and ponds containing heavy growth of algae to using QUAD ALGAEQUELL.

For pools having just visible algae growth add an initial fluid ounces of QUAD ALGAEQUELL per 10,000 gallons of water. Remove settled algae debris by cleaning. For treatment of a pool that has had algae growth, add initially 27 to 50 fluid ounces of QUAD ALGAEQUELL per 10,000 gallons of water. Subsequent additions of 9 fluid ounces of QUAD ALGAEQUELL per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, decorative fountains, and ponds with algae growth require an initial dose of 5 fluid ounces of QUAD ALGAEQUELL per 1000 gallons of water. For a cleaned spa, whirlpool, hot tub, decorative fountain, or pond, add 5 fluid ounces of QUAD ALGAEQUELL per 10,000 gallons of water. Subsequent additions of 1 to 5 fluid ounces of QUAD ALGAEQUELL should be made every 7 days for maintenance.

QUAD ALGAEQUELL will prevent algae growth during the off-season winter months when pools are not in use.

Pools that are regularly treated during the swimming season and are free of algae growth require 43 fluid ounces of algacide per 10,000 gallons of water. If season pools have some visible algae growth, add 50 fluid ounces of QUAD ALGAEQUELL per 10,000 gallons. It is necessary that a uniform distribution of water and the pool be made for maximum effectiveness. It may be necessary to repeat the treatment one or more times during the season.

QUAD ALGAEQUELL is compatible with other chlorine products used to treat pools and spas and is effective against algae. QUAD ALGAEQUELL can be used in conjunction with chlorine chemicals and may reduce the amount of those chemicals required. However, do not mix QUAD ALGAEQUELL with other chlorine products.

STORAGE & DISPOSAL: Do not contaminate water, food, or feed. Keep container closed when not in use. Leaking or broken containers should be placed in a plastic bag and discarded in trash. All pesticides should be kept out of reach of children.

DISPOSAL: Do not reuse empty container. Wrap
