4. Revise the ingredient statement to read as follows:
Active Ingredient: Metallic Silver.....0.1%
Inert Ingredients: Active Carbon.....99%
3. Place the subheading, "Directions for Use" directly above the statement "For use in thewater."
4. Place the misuse statement to read as follows; "It is a violation of Federal Law to use this product in a manner inconsistent with its labeling" directly below the subheading "Directions for Use."
5. Revise the phrase "oders" to read as follows "odors."
6. The "Net Contents" statement should read as follows;
" Net Contents: One Bacteriostatic Water Filter Cartridge"

A stamped copy of the product label is enclosed for your records.

Submit one copy of the final printed labeling before releasing the product in channels of trade with the revised labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
