LABELING: (Statements are based on review of referenced acute toxicity data)

1. The signal word is "DANGER"

2. Revise the Precautionary Statements to read:

CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. For control of bacteria in swimming pools, operated continuously.

RECOMMENDED DOSAGE

- 1) Before bathing, test pool water for chlorine and alkalinity using a suitable test kit. Adjust alkalinity to 1-2 ppm. Use a chlorine stick to prolong chlorine residual between 7.2 and 7.6 ppm and 175 ppm.
- 2) Place sticks in skimmer basket or on tablet feeder to maintain chlorine residual. Do not use this product in the skin.
- 3) Weekly, superchlorinate pool water to a suitable superchlorination level. See the product label for instructions.
- 4) Reentry into pool is prohibited above level.

STORAGE
