ISOCYANURATE RED ATTACHEMENT A

LABELING: (Statements are based on review of referenced acute toxicity data)

1. The signal word is "DANGER"
2. Revise the Precautionary Statements to read:

CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

3. Revise the Statement of Practical Treatment to read:

STATEMENT OF PRACTICAL TREATMENT.

IF SWALLOWED: Drink promptly large quantities of water. Do not induce vomiting. Avoid alcohol. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably, mouth-to-mouth. Get medical attention.

DANGER

CORROSIVE:

PHYSICAL OR CHEMICAL HAZARD

DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with the label.

DURATABS are slow release tablets for continuous chlorination.

RECOMMENDED DOSAGE: For pool water, place 10 tablets in skimmer basket. Allow 6 to 12 hours to equalize. Initial treatment depending on water quality. If water is maintained between 1.0 and 1.5 ppm, a suitable test kit, if available, should be used to level to be low. Increase dosage if water level to be higher than 1.5 ppm. Add tablets accordingly.

Once every two weeks a water sample should be made to check for resistant species of algae. For GRANULAR used at the rate of 100 lbs per 100,000 gallons of water will saturate in conjunction with DURATABS at 7.2 and 7.6 as determined by test kit.

Reentry into treated swimming pool above levels of 3 ppm is prohibited.

STORAGE

Do not contaminate water. Dispose of unused product.

STORAGE: Keep material in original container when not in use. Store in a cool, dry area away from heat and fire. CONTAINER DISPOSAL: Rinse empty container thoroughly with all material before collection or disposal. IF CONTAMINATION: Reseal container. If possible, use in well ventilated area. Do not breathe water, avoid breathing material in an approved manner.
