Dear Mr. Fortier:

The Agency has reviewed your amendment submitted in accordance with continuing registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended, and determined the action acceptable with the following conditions:

- Move the treatment "If In Eyes" to the top of the First Aid statements followed by If On Skin, If Inhaled and If Swallowed.
- Under "Hazard to Humans and Domestic Animals" change "wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco" to "wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet."
- Under the Directions for Use, revise the use of the shock product instructions to read "STABILIZED GRANULAR used in accordance with that product's directions will satisfy this requirement when used in conjunction with 1" TABLETS.
- Under Container Disposal delete "Offer for recycling, if available" and add as last sentence: "Offer for recycling, if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities."

In summary, you have changed the primary brand name from Dura Tabs to Durachlor 1" Tablets and revised Storage and Disposal instructions in accordance with PR Notice 2007-4.

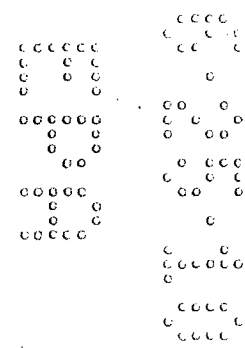

PHYSICAL OR CHEMICAL HAZARDS

STRONG OXIDIZING AGENT.

Contact with water slowly liberates irritating and hazardous chlorine containing gases. Decomposes at temperatures above 464°F with liberation of harmful gases. When ignited, will burn with the evolution of chlorine and equally toxic gases. NEVER add water to product. Always add product to large quantities of water. Use clean, dry utensils. DO NOT add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic material, or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible fire and explosion.

IN CASE OF FIRE OR SMOKE:

Call the fire department. Do not attempt to extinguish the fire without a self-contained breathing apparatus (SCBA). Do not let the fire burn. Flood with copious amounts of water. DO NOT use ABC or other dry chemical extinguishers since there is a potential for a violent reaction.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. 1" TABLETS are stabilized slow dissolving tablets to provide continuous chlorination to control bacteria and algae.

RECOMMENDED DOSAGE: For each 15,000 gal. of pool water, place 10 tablets in the skimmer basket. Allow 6 to 12 hrs. for chlorine residual to equalize. Initial treatment will last from 2 to 4 days depending on water temperature and flow rate through the skimmer. Chlorine residual should be maintained between 1.5 and 2.0 ppm as determined by a suitable test kit. If daily testing indicates the chlorine to be low, increase the number of tablets in the skimmer basket. If daily testing indicates the chlorine

level to be low, increase the number of tablets in the skimmer basket. If daily testing indicates the chlorine level to be higher than 2.0 ppm, reduce the number of tablets accordingly. Once every two weeks a shock dose of 5 ppm chlorine should be made to prevent the development of resistant species of algae. 1" TABLETS are not recommended for this purpose. STABILIZED GRANULAR used at a rate of 1/2 lb. per each 10,000 gallons of water, will satisfy this requirement when used in conjunction with 1" TABLETS. Keep pH of water between 7.2 and 7.6 as determined by a suitable test kit. Reentry into treated swimming pool is prohibited above levels of 3 ppm of chlorine.
