Dear Tyler Thoms:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Interim Decisions for both the copper compounds and polixetonium chloride (Busan 77), and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process, FIFRA section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. 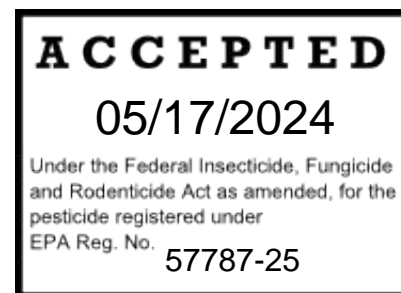

[Combat Extra] [This product] is used to eliminate and control all types of stubborn pool algae growth in swimming pools. Not only does this product rid pools of algae, our unique formula contains a special clarifying agent to help clear water fast. [Combat Extra] [This product] can be used routinely, with most chlorine and bromine sanitizing systems, for water that remains algae free during the year.

[There are three important steps to follow to maintain sparkling clean water [in your pool]:]

[Step 1 – Add SANITIZER] or [DISINFECTANT] to control bacteria.]

[Step 2 – Add SHOCK to destroy contaminants.]

[Step 3 – Add ALGAECIDE to prevent algae before it starts.]

[All three steps are vital to achieve sparkling clean water.]

Prior to Application

Clean the pool filter as necessary following the manufacturer's instructions for backwashing or using a filter cleaning solution. Adjust pH of pool water to the ideal range of 7.2 – 7.6. Prior to using this product, pools with heavy algae growth must be vacuumed. If the pool is properly equipped, the vacuumed algae growth must be vacuumed directly out of the pool to waste.

Treatment of Visible Pool Algae

Superchlorinate pool water prior to application and circulate 1 to 2 hours before moving to next step. Pools having light to medium pool algae growth, add 16 fluid ounces of [Combat Extra] [this product] per 10,000 gallons of water directly to the pool with the pool pump operating. Pools with heavy algae growth, add 24 fluid ounces per 10,000 gallons of water. Brush pool to increase circulation and to remove algae from pool walls and bottoms. Black algae must be brushed vigorously before and after application for best results. After applying, continuously operate pool pump for 24-48 hours. In cases of persistent algae, repeat brushing and product application after 3-4 days. [Once pool is clear, clean the filter with a filter cleaning solution.]

Algae Prevention

For treatment of freshly filled, cleaned, or restored pools, add 16 fluid ounces of [Combat Extra] [this product] per 10,000 gallons of water directly into the pool. Maintenance additions of 4 fluid ounces of [Combat Extra] [this product] per 10,000 gallons of water must be made every 7 days after initial treatment. Additional applications may be needed after heavy rains. Brushing pool surfaces weekly will greatly reduce the chances of pool algae appearing.

Prior to Application

Clean the pool filter as necessary following the manufacturer's instructions for backwashing or using a filter cleaning solution. Prepare your pool for the closing season by adjusting pH of pool water to the ideal range of 7.2 – 7.6. Consult your dealer for ideal total alkalinity and calcium hardness levels during winter months for your pool type and geographic location.

Algae Prevention During Off-Season

Superchlorinate pool water prior to application and circulate 1 to 2 hours before moving to next step. When pool water is balanced and free of visible algae, add 16 fluid ounces of this product per 10,000 gallons of water. Add this product with the pump running before draining to desired winter levels and placing winter cover. It is necessary that a uniform distribution of this product throughout the pool be made for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment additional times during the season, consult your dealer.
