The following notification submitted in connection with registration under the provisions of PR Notice 98-10, Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)9 is acceptable.

- Addition of batch code

General Comments:

Based on a review of the material submitted, the following comments apply:

Revise the container disposal section by adding the following statements after the phrase "Triple rinse (or equivalent)."

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

This application for notification to revise the product label, as referenced above, is acceptable. A copy has been placed in our records for future reference. Please note that the name of this product "ProTeam" may not be acceptable by Agency standards. The Agency does not allow "Professional" or any inference to Professional (i.e., Pro) on pesticidal labels. You must contact the Agency as soon as possible to discuss this issue.

No other changes have been made to the labeling or the Confidential Statement of Formula for this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if the amended label is not consistent with the requirements of 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA."

ProTeam Supreme is specially formulated to enhance water quality by improving filtration and controlling algae. Use of this product promotes sparkling, clear water and reduces eye and skin irritation for swimmers.

Supreme provides long-lasting algae suppression, controlling all types of algae found in swimming pools, as well as aiding in the removal of existing algae stains.

- For initial application, introduce two pounds of ProTeam Supreme per each one thousand gallons of pool water by broadcasting the material over the surface area of the pool with a pump running. This initial treatment should be added in two doses with one half of the necessary amount being added in each application. For initial pH adjustment use ³/₄ pound ProTeam pH Down (Sodium Bisulfate) or 10 ounces of muriatic acid for each pound of ProTeam Supreme, mixing acid in a bucket of water, then add to pool.
- 2.) The pH of the pool water may rise as a normal reaction to the introduction of ProTeam Supreme. After a normal turnover of pool water adjust the pH to 7.4-7.6 using a reliable acid demand kit. ProTeam Supreme is compatible with all materials normally used in swimming pool maintenance.
- 3.) Test the pool water a minimum once a week or as normally required by local Health Authority Regulations. Sanitizer levels need to be maintained at levels indicated on the sanitizer label. The **ProTeam Supreme** residual should be tested at least once each month and should be maintained at 30-50 ppm. Your ProTeam Dealer can provide this test and water analysis.
- 4.) ProTeam Supreme is lost from water only through filter backwash and splash-out.

WINTERIZATION

A pool that has been treated with **ProTeam Supreme** will remain clear and be beautiful throughout the winter months with little or no effort. The pool should be tested to assure that an adequate level of **ProTeam Supreme** is present before shut down. See you ProTeam Dealer for freeze protection information.

STORAGE AND DISPOSAL

(Household / Residential Use)

Nonrefillable container. Do not reuse of refill this container. Securely wrap original container in several layers of newspaper and discard in trash or offer for recycling if available.

(Commercial / Industrial / Institutional Use)

Do not contaminate water, food, or feed by storage and disposal.

Pesticide Storage: Store in original container in a locked area inaccessible to children or pets. Storage areas should be cool and dry. Keep container tightly closed.
