## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS WARNING

## **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**ProTeam Supreme** is specially formulated to enhance water quality by improving filtration and controlling algae. Use of this product promotes sparkling, clear water and reduces eye and skin irritation for swimmers.

**ProTeam Supreme** provides long-lasting algae suppression, controlling all types of algae found in swimming pools, as well as aiding in the removal of existing algae stains.

- For initial application, introduce two pounds of **ProTeam Supreme** per each one thousand gallons of pool water by broadcasting the material over the surface area of the pool with a pump running. This initial treatment must be added in two doses with one half of the necessary amount being added in each application. For initial pH adjustment use <sup>3</sup>/<sub>4</sub> pound ProTeam pH Down (Sodium Bisulfate) or 10 ounces of muriatic acid for each pound of **ProTeam Supreme**, mixing acid in a bucket of water, then add to pool.
- 2.) The pH of the pool water may rise as a normal reaction to the introduction of **ProTeam Supreme**. After a normal turnover of pool water adjust the pH to 7.4-7.6 using a reliable acid demand kit. **ProTeam Supreme** is compatible with all materials normally used in swimming pool maintenance.
- 3.) Test the pool water a minimum once a week or as normally required by local Health Authority Regulations. Sanitizer levels need to be maintained at levels indicated on the sanitizer label. The **ProTeam Supreme** residual must be tested at least once each month and must be maintained at 30-50 ppm. Your ProTeam Dealer can provide this test and water analysis.
- 4.) **ProTeam Supreme** is lost from water only through filter backwash and splash-out.

## WINTERIZATION

A pool that has been treated with **ProTeam Supreme** will remain clear and be beautiful throughout the winter months with little or no effort. The pool must be tested to assure that an adequate level of **ProTeam Supreme** is present before shut down. See your ProTeam Dealer for freeze protection information.
