It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

POSACYDE - W is used to control bacteria, algae, and fungi in recirculating commercial and industrial air wash systems. To its use, systems must be cleaned to remove algae, slime, and other deposits. An initial slug addition of POSACYDE - W fluid ounces of POSACYDE - W of water to provide a concentration of 48 to POSACYDE - W, based on the system, is recommended. Repeat initial dosage Subsequent slug additions of 1.53 to POSACYDE - W per 1000 gallons of 120 parts per million of POSACYDE - W employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the problem. Slug additions should be made in the sump of POSACYDE - W is used to clean air-washing systems that maintain effective mist eliminators. To its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 to POSACYDE - W per 1000 gallons of 16.9 to 41.2 fluid ounces of POSACYDE - W per 1000 gallons of water should be employed each 1 to 5 days. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the sump or collection trays of the airwash system.

**STORAGE AND DISPOSAL**

- STORAGE:** Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill when not in use.
